With the grace of the Almighty we are near completion of Phase 1 of the Project and have alhamdulillah spent £300k on the renovations listed below:

Phase 1

1. Shopfront of the Mosque
2. Mosque entrance and stairs
3. Extension and renovation of the daily prayer hall
4. Extended ladies prayer facilities
5. Wudhu facilities
6. Air conditioning for daily prayer hall and ladies prayer facilities
7. Lift
8. New boilers
9. Underfloor heating
10. New electrical wiring
11. Restrooms (basement and first floor)

We are appealing for a further £450,000 which is needed for the completion of Phase 2 work as outlined below:

Phase 2

1. Modernisation and decoration of main prayer hall
2. Electrics and lighting
3. Carpets (daily and main prayer halls)
4. Air conditioning of other areas
5. Sound system
6. Heating system
7. Security and fire safety equipment
8. Disabled access

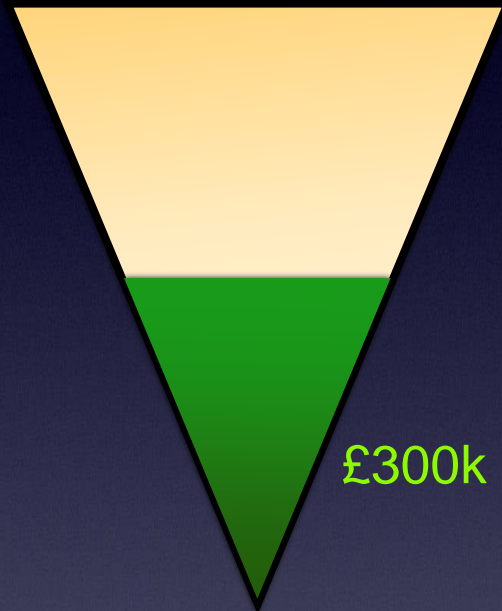
